ACGH is looking for passionate and committed candidates for key leadership roles who are interested in building a strong voice for global health within ASTMH that places the Society in a leadership role in the larger global health arena.

- **President-Elect** (serves a three-year term: one year as President-Elect, one year as President and one year as past President).
- **Secretary/Treasurer** (two-year term).
- **Two Councilors** (two-year term).
- **Trainee Councilor** (two-year term).

The Global Health Subgroup includes U.S. and international members from non-profit associations and institutions, academia, private sector and government.

Global Health Subgroup goals include promoting the development of the global health field, increasing educational efforts on global health issues, facilitating dissemination and publication of global health research and stimulating interest in a global health career path.

Interested candidates are asked to provide the following information:

- A maximum two-page statement briefly outlining the qualities and skill set that you would bring to this volunteer position. Please include an overview of professional qualifications. List any committee work within ASTMH or at similar societies or institutions. Word document only please.
- One-page narrative bio. Word document only please.
- Current high-resolution headshot photo.

Interested candidates should submit the requested information online by Monday, July 21, 2024.

Global Health Subgroup requirements and information:

- Candidates must be passionate about the mission and goals of the Global Health Subgroup
- Candidates must be eager to be actively engaged in identifying new strategies to grow the Global Health Subgroup's membership, revenue and other activities
- Candidates should reflect the overall Society's diversity in geographic location, gender, age, race, ethnicity, professional experience and work setting
- Candidate is a member in good standing in ASTMH and the Global Health Subgroup (dues are paid and current)
- Terms are three years for President-elect and two years for Councilor
- There is no compensation for terms served

Specific Expectations:

- Actively participate in all Global Health Subgroup conference calls and meetings
- Actively engage in building a diverse membership through individual as well as collective efforts
- Work in a timely, efficient and outcome-oriented manner

Council Responsibilities:

- Work with fellow Councilors to determine and establish long-term goals
- Strive to maintain focus on the mission, values and goals of the Global Health subgroup that then complement that of the Society
- Proactively seek new funding, programs and projects to enhance the goals and mission of the Global Health Subgroup
- Monitor current programs for relevance and effectiveness
- Maintain an open dialogue with ASTMH staff

Timeline for decision making:

The slate will be developed in July, and the election will take place in August. Results will be announced prior to the November Annual Meeting. Terms begin immediately following the Annual Meeting, November 9-13, 2025.
