**II. Introductions**

Welcome to the new Trainee-Councilor Devika Sirohi, Graduate Student, Purdue University.

Thank you to Jonathan Auguste, the Departing Trainee-Councilor. Council members identify themselves and others introduce themselves.

**III. Council Membership**

To amend bylaw to change term of service to keep membership at 8 councilors, we need a vote from all members.

**Discussion**

Ksiazek: ACAV is not part of ASTMH even though we run our elections through ASTMH.

Hanley: We need to bring in 2 new counselors soon. For a total of 4 new councilors next year but we do not want 4 to rotate off as a chunk.

Powers: Why 8?

Hanley: 4 rotating per year. 2 on, 2 off.

Powers: Amend rotation schedule?

**IV. ACAV Symposium 2017**

Possible topic hosted by Kramer and Greg Ebel: Tick-borne Viruses. This was initially the idea for 2016 but it was pulled this year in favor of a ZIKV symposium.

Q: Is Shope awardee presenting in business meeting? (Requirement of Shope award). A: Yes.

**V. Archives**

Don Burke has not been active in archiving and would not like to continue. There are currently 124 ACAV-related boxes of archived materials at Harvard who own.

Requires \$30K to store and catalogue.

**Discussion**

Fred Murphy might have some passion as an archivist.

What about transfer to Rockefeller group?

Vasilakis: we need a sugar daddy, financial support

3rd party companies will scan for cheap, cost might be in archiving it.

Karen Goralski of ASTMH says cataloging part incurs most expenses.

Hanley: Get concrete estimate of cost.

Powers: Parent council is looking into it right now so maybe we shouldn't duplicate efforts.

**VI. Pre-meeting course with ACME in 2016**

Topic 'Know Thine Enemy: Methods to Identify Mosquitoes and the Viruses They Carry'

57 students enrolled.

Topics ranged from mosquito taxonomy, spatial distribution of arboviruses, vector competence, how to isolate, serologic methods, how to use molecular methods to ID viruses.

Attendees were a balance between professionals and trainees

Excellent promotion of ACAV

Hanley: It worked well to split work with 2 groups, i.e. division of labor between 2 organizers.

Lots of paperwork for CME courses. In future, Hanley suggests division of labor.

**Discussion**

Do we want to do a 2017 course? With ACME? With another group, e.g. global health?

Ideas: Use of citizen science for outbreaks, Clinical Complications of Arboviruses

LaBeaud: Does ACAV make money off the courses? No. ASTMH might. Courses cost ASTMH \$50k (all). Clinical courses are longer so may be more expensive.

What is the cost per student? \$150

Professionals: \$260

Mores: some pressure from parent society to do it.

Q: Why? A: Unclear. Merit? CME?

What ways does ACAV value a pre-meeting course?

Hanley: ACAV has an educational mission that this course fills. It also facilitates activities between subgroups.

Weaver: How much time did it take to organize?

Hanley: 40-50 hours

Weaver: What happens where there is not an active ACAV chair?

Q: What are the metrics? A: Pre-course quiz. Post-course quiz. Post-course survey and open section for comments. Survey for speakers too.

Hanley: If CME templates are in place, the course will be easier.

Coffey volunteers to lead 2017 course.

**VII. Report from Treasurer, Weaver**

It is challenging to get details from Society so the current budget report is >4 months old.

Our ledgers have declined by \$500. We are running in the red by \$500 compared to last year.

We started offering travel awards (n=3), ASTMH pays for an additional 2.

Dues were raised a little.

**Discussion**

Q: Raise funds from big pharma?

Hanley: ACME is good at soliciting sponsorships. Easiest to accept: student travel awards.

Total: \$33K. Stable for a few years +/- \$1K.

Mores: more ACAV branding on travel awards might me more ACAV memberships

ACAV membership income \$2,700 this year.

Other expenses: new plaques. We have a 5-10 year stock of plaques at present.

Hanley: Ways to increase revenue stream:

1. Be more active about soliciting ACAV subgroup membership for new members.
2. Get more information during sign up of new members.
3. Give less travel awards.

Q: What would we do with more money? A: Give more travel awards? ASTMH is double the cost of ASV.

Q: How many ACAV travel award applicants are there? A: No one knows. Greg Ebel might know but he is not present.

### VIII. Networking

We got more active at this meeting with mentorship activities.

'Speed dating/networking': 10 mentors

'Luncheon roundtable': ACAV councilors and members all invited, 3 Pls per room, Advertising by email, Low response rate: 12-15, Hoping for larger turnout. Walk-ins okay, lunch from ASTMH can be taken into rooms.

Potential problems: Conflicts with poster time. Competes with speed-networking.

Possible solutions to increase attendance:

Kramer: put advertising sign on bulletin board.

Announce at student session where free alcohol is offered.

Poll trainees to ask what they want instead of just inferring what we think they want in the form of mentorship?

### IX. Hill Visit

Hanley went to Washington, DC in May at the mid-year ASTMH meeting to advocate for release of ZIKV funding.

She visited Ted Cruz' office. The visit was largely ineffectual.

Recipient: Jack Woodall

He received the award shortly before he died of pancreatic cancer.

Issue Shope award, Dalrymple/Young Award at the meeting this year.

Q: What is the philosophy for these awards?

A:

1. Contribution to arbovirology?
2. Service to ACAV and excellence in research?
3. Reach out to would-be ACAV members?

#### Discussion

Powers: should not be a mechanism to get people involved in ACAV.

Tesh: ACAV membership should not be required. Remove language in award nomination.

Ksiazek: More fundamental discussion: who is a member of ACAV? Just attending meeting and signing form?

General consensus: remove ACAV membership requirement from award descriptions.

Also, request simplification of membership forms.

General agreement.

## GUIDELINES FOR THE AMERICAN COMMITTEE OF ARTHROPOD-BORNE VIRUSES

During the 1987 executive council meeting of the American Committee on Arthropod-borne Viruses (ACAV) in Los Angeles, it was agreed that guidelines for the committee need to be established and recorded in a single document. The ACAV currently operates under procedures that are stated in various reports. A summary statement of the ACAV organization would assist new executive council members and chairpersons in understanding how the committee operates. In addition, modifications in procedures could easily be incorporated into a centralized body of information.

The information that follows is intended only as a guide for the ACAV organization; goals of the ACAV are stated in other publications. During the formation of ACAV it was agreed that the group would not be a formal organization with by-laws. Rather, it would provide a forum for exchange of information among people interested in arbovirus research.

The ACAV meets annually in association with the American Society of Tropical Medicine and Hygiene (ASTMH). An executive council is the governing body of the ACAV. The council is chaired by a person

who directs council and committee meetings and retains the ACAV files. The chairperson of the executive committee serves a 4-year renewable term and is elected by the executive council at the annual council meeting. The council consists of six people who each serve a 4-year term. New council members are elected by members of the ACAV. Council members who are rotating off form a search committee that nominates council candidates; the slate of candidates must be approved by the existing council. The chairperson of the council sends ballots to the ACAV membership. The candidates who receive the most votes are notified and take office at the next annual meeting of the ACAV. There is no quorum for the election of officers or for other council and committee votes. Should a member of the executive council resign or leave the ACAV, a new council member is appointed by the executive council to complete the original member's term.

Other ACAV positions include a secretary, treasurer, historian and international advisors. The secretary is the newest member of the council and records minutes of the council meeting. The treasurer is

appointed to a 4-year renewable term by the executive council and maintains the ACAV funds in a subaccount of the ASTMH. Withdrawals and deposits from the ACAV account are arranged with the treasurer. The council chairperson must approve all withdrawals, and the council must be consulted for withdrawals of \$100 or more. The historian is designated by the council and provides historical information on the operation of the ACAV. The council selects international advisors, determines the number of advisors, and defines the length of the advisor's terms.

All people interested in joining the ACAV may do so by attending a meeting and signing their name to the attendance sheet. Membership in the ASTMH is not a requirement for membership in the ACAV. People missing three consecutive meetings will lose their membership in the ACAV. Exceptions to this attendance rule are made for people with emeritus status and for some overseas participants. Emeritus status is automatic upon retirement. The executive council must approve an attendance exception for people living overseas.

Subcommittees are an important part of the ACAV and are formed when sufficient interest is presented to the executive council by ACAV members. The council reviews proposed subcommittees and decides whether a particular subcommittee is needed. When council approves the formation of a subcommittee, it appoints a chairperson. The subcommittee chairperson, in consultation with the ACAV chairperson, appoints subcommittee members. New subcommittees formalize their objectives and structure. All subcommittees report progress on objectives at the annual meeting to the ACAV.

The ACAV presents three awards, when appropriate, in staggered three-year intervals. The chair of the executive council appoints a nominating committee for each award. Recipients of awards are selected by the executive council. An announcement requesting nominations for each pending award is published in the *Tropical Medicine and Hygiene News* at least six months prior to the ASTMH annual meeting. This procedure provides the nominating committee with nominations and documentation from ACAV members. The Scherer/Hardy Award is given to an outstanding graduate either before graduation or up to 3 years post-graduation. Accrued interest from the account for this award is used to defray costs associated with the student's participation at the annual ASTMH meeting. The council chairperson may use general ACAV funds to assist in this effort. The Dalrymple/Young Award is given to a mid-career investigator who has made an outstanding contribution to arbovirology. The Richard M. Taylor Award is given to a person who has made outstanding contributions to arbovirology throughout his or her career. Medals for the Young and Taylor Awards are retained by the treasurer until they are requested by the chairperson for presentation at the annual committee meeting.

In addition to award presentations, the agenda for each annual meeting includes old and new business, epidemic reports, and a symposium on a relevant topic. Prospective symposium topics are discussed by the executive council and solicited from the committee membership, but the final decision on what will be presented is determined by the chairperson.
